## **Digital Citizenship**




Digital Citizenship is "the use of technology resources in safe, responsible and legal ways."

#### **Analyzing the Survey Data**

The Digital Citizenship survey was emailed to twenty-two people, eighteen of those persons responded.

The age range of the participants and percentage were as follows:

**Age:** 15-18 (11.1%)

**Age:** 20-20 (16.7%)

**Age:** 30-39 (0%)

**Age:** 40-49 (44.4%)

**Age:** 50-59 (11.1%)

**Age:** 60-69 (16.7%)

**Age:** Other (0%)

#### **Ethnicity of the participants:**

African American/Black (55.6%)

White (38.9%)


Hispanic/Latino (5.5%)




## **Analyzing the Survey Data**

#### **Digital Citizenship**

- 72.2% of the participants reported they know that digitizenship is the use of technology in a responsible manner by those who use computers.
- 11.1% Reported that digital citizenship Is showing respect by using online Etiquette.






- ★ *Digital Footprint*-50% of the participants reported being somewhat familiar with the term.
- ★ *Tech Savvy* 9 of the 18 reported they are somewhat tech savvy.
- ★ <u>Digital Etiquette</u>- 88.9% reported having a special ringtone was is an example of Digital Etiquette, while 11.1% believed that is not an example.

#### **Digital Access-**

• 94.4% reported to believe digital access is the ability to be engaged in technology.

5.6% reported to believe it is having a special code to use internet discounts.






## Analyzing the Data DO YOUR PART TO **STOP** CYBERBULLYING

18 responses






→ Eight of the eighteen participants reported they feel safe using Antiviral Protection Software.

- **94.4%** of the participants reported believing digital wellness is the process of developing a healthy and balanced relationship with technology.
- 88.9% of the participants reported that digital law is the rights and restrictions that govern technology use.
- **88.9%** of the participants reported knowing that digital piracy is the illegal ownership and online distribution of digital music, software or movies.
